Entertainers

We invite family-friendly entertainers of all ages and genres to perform. If you are new to the market, please submit a sample recording for review. The Market provides entertainers with a 10'x10' canopy, PA system, microphone, and mic stand. Acts are typically scheduled for two hours (shorter or longer performances can be negotiated). Entertainers receive a small stipend.

Nonprofits

We waive the booth fee for eligible nonprofits at one market per season (chosen from the available dates listed above).

Agencies who wish to engage in pre-approved fundraising activities or attend more than one market per season must submit a Non-Food/Arts & Crafts Vendor Application. Daily vendor rates apply.
